1. Important Dates

2. ICBF Board

The Board met on Thursday this week and welcomed Tom Wilson a dairy farmer from West Cork who has been appointed by ICMSA. He replaces Kevin Connolly who has served on the Board since 2000.

At its meeting the Board:

- ♣ Endorsed the agreement for the introduction of catalogue services in conjunction with ICBF's Herd Book members.
- Was advised that consideration of a request by beef Herd Book members for the appointment of additional beef expertise was currently on hold pending the outcome of the current review of breeding schemes.
- ♣ Approved, on the recommendation of the Audit & Finance Sub-Committee, ICBF's application for NDP funding for 2011.
- 4 Agreed to consider the membership of the Audit & Finance Sub-Committee at its September meeting.
- Considered and approved the development and promotion of IGenoP by ICBF. (A description of IGenoP can be found publications section of www.icbf.com).
- ♣ Was informed of the scope and importance of the relationship between ICBF and Teagasc.
- ♣ Agreed that ICBF seeks certification for Code-EFABAR as an umbrella organization and facilitates certification for those of its members that are interested. (Details of Code-EFABAR can be found here http://www.effab.org/CODEEFABAR.aspx).
- Reviewed the outcome of the recent ICAR and Interbull meetings held in Riga and to be hosted in Ireland in 2012
- Was briefed on the discussions that are currently taking place as part of the Breeding Scheme Review. Further work in currently being undertaken and will be reported later in the year.

3. Sheep Ireland Board

The Interim Sheep Board met on Thursday this week.

At its meeting the Board:

- Approved, on the recommendation of the Audit & Finance Sub-Committee, Sheep Ireland's application for NDP funding for 2011.

- Received and discussed a presentation from the Chief Executive on future directions for Sheep Ireland.
- Reviewed the outcome of the recent ICAR and Interbull meetings held in Riga and to be hosted in Ireland in 2012.









4. Database





- ♣ The stats above are compiled with the assistance of DAFF AIM systems.
- In the Suckler scheme, the number of 2009 born calves with meal introduced is 650,964 with the number of animals weaned at 587,243.
- ♣ A significant update to the suckler scheme keying screens has gone live this week.
- ♣ Vets wishing to begin interacting with the AHI/ICBF system can register at http://www.animalhealthireland.ie/registerpage.php.
- Work is continuing on a web tool to help manage the storing of samples used in the genomics process at ICBF.
- The new Embryo Transfer (ET) screens for herdbooks are now live.
- Work is ongoing on the window server infrastructure, involving a move to a more resilient infrastructure for email, and file servers.
- ♣ Work on a new infrastructure for communicating with marts is on-going, with a view to getting the data flows on a more efficient and effective basis.
- The graph shows Inseminations recorded on AI Handhelds in 2010 compared with 2009.



5. Genetic Evaluations

- ♣ All extracts have now been performed ahead of the August routine evaluations for dairy and beef.
- Preparation of pedigree files for genetic evaluations has begun.
- ♣ Work on various research topics is being finalised ahead of the beef and dairy industry meeting next week.

6. Sheep Ireland

- ♣ The 2010 results for the CPT Rams are now up online www.sheep.ie
- Genetic Evaluations continue to be distributed to all Lambplus Breeders. Once they have all been distributed they also will be put up online.
- The DNA parentage results are currently being received for the commercial MALP Lambs. Once this data has been loaded and the genetic evaluation results have been created these results will then be distributed and the results also put up on the web.
- Weight reports are currently being sent to all MALP & CPT farmers. These reports summarise all of the weighings that have taken place on these flocks in 2010.
