





2 Database



- **4** The stats above are compiled with the assistance of DAFF AIM systems.
- In the Suckler scheme, the number of 2011 born calves with meal introduced is 582,179 with the number of animals weaned at 497,422.
- The 5 Year Trend report will be going out to all Suckler Scheme participants over the coming weeks, along with a Suckler Cow 'Milk and Docility' survey. Farmers will also receive their annual supply of freepost Animal Events envelopes.
- BVD test results continue to be received at ICBF and are being processed accordingly. Around 7,800 herds have purchased a total of 469,000 tissue tags for BVD testing at this stage. Around 40,000 samples have been returned at this stage, with a 0.68% BVD PI Positive rate.
- The development of a new 'Bull-Tracker' report for pedigree herds is on-going and will be entering pilot testing over the next couple of weeks.
- A weight recording report is under development at the moment, which will be distributed to farmers involved in weight recording after each submission of weights.
- Some further developments to enhance the loading of genotype information to the database is continuing.
- The graph shows Inseminations recorded on AI Handhelds in 2012compared with 2011.







4 Genetic Evaluations

Genomics

The first run of genomic evaluations using the LD chip were loaded to the database yesterday. Herd-owners now have updated profiles and reports have been generated. Genotypes continue to come in at a rate of almost 900 per week. The next results will be available next week.

Weight Prediction

Three pieces of work related to weight prediction have started:

- Update of the prediction equations of live weight pre-slaughter using slaughter records and early live weight records. This work is near completion and new equations will be implemented when finalised.
- Prediction of live weight at a given age. This work is using live weight records on a reference population of animals to approximate the growth curve, and can then predict-forward live weights to specific ages. This work is under development.
- Prediction of birth weight using linear measurements recorded on the calf. The objective is to have a reliable proxy for birth weight using measurements like chest circumference, canon dimension, height at shoulder, and/or length of back. This work is on-going as records of weights and measurements are currently being taken on selected farms.

5 Sheep Ireland

4 Our meeting with our pilot project breeders in Northern Ireland last Friday was extremely positive. There were a number of breeders that made the trip over from Scotland to see how Sheep Ireland was operating and the potential of the €uro-Stars in the Irish sheep industry. Overall the group was very complementary about what was happening in Sheep Ireland, especially in regard to the progress that was being made. The general consensus at the end of the meeting was that there is great potential within the scheme for both the pedigree and commercial farmer. Greater collaboration between Sheep Ireland and our equivalent in the UK was seen as essential, in order to deliver maximum genetic improvement in both countries. The number of pedigree breeders







in Ireland currently sourcing stock from the UK is high, and this highlights the need for Sheep Ireland to have the ability to incorporate Signet performance data in our evaluation model – and vice versa.

- Over the coming week we will continue to help breeders record their 2012 lambing data on our database. We have a number of meetings to attend in the midst of this work. On Wednesday evening we will meet with Lamb Producer group representatives to outline the potential benefits that can be accrued from using high theorem areas. This will be a great opportunity to explain the Sheep Ireland evaluation system to those whom we feel will gain greatly from this technology.
- In Thursday our MALP (Maternal Lamb Producers Group) will be meeting with Sheep Ireland representatives to discuss plans for the coming year and to deliver some training to participating farmers on recent improvements to the recording systems which they will be using in 2012. On Thursday evening we will be speaking to members of the National Sheep Breeders Association, to give an update on where Sheep Ireland are presently and our objectives are for 2012. Again, this will be a great opportunity to promote €uro-Stars and educate more industry leaders to the potential that exists for genetic gain and the financial gain that will result.
