





# ICBF Weekly Update 24th February 2012

#### 2 Database






- ♣ The stats above are compiled with the assistance of DAFF AIM systems.
- ♣ In the Suckler scheme, the number of 2011 born calves with meal introduced is 584,903 with the number of animals weaned at 502.458.
- Distribution of the 5 Year Trend report has begun this week to all Suckler Scheme participants along with a Suckler Cow 'Milk and Docility' survey. Farmers will also receive their annual supply of freepost Animal Events envelopes.
- ♣ BVD test results continue to be received at ICBF and are being processed accordingly. Around 493,000 tissue


tags for BVD testing have been purchased at this stage. Around 73,000 samples have been returned at this stage, with a 0.61% BVD PI Positive rate.

♣ Pilot testing has begun on the new 'Bull-Tracker' report for pedigree herds.



♣ Some further developments to further enhance the loading of genotype information to the database is continuing.

♣ The graph shows Inseminations recorded on AI Handhelds in 2012compared with 2011.










# 3 G€N€IR€LAND®

## **Dairy**

- ♣ A new genomic run was completed this week with just over 1000 dairy animals receiving a genomic EBI.

#### 5 Sheep Ireland

Sheep Ireland made presentations to three groups this week:

- We were kindly invited to the IFA annual Lamb Producers Group meeting which took place in Portlaoise on Wednesday evening. Speaking to groups like this is exactly where we need to be, as these are the ultimate beneficiaries of the €uro-Star evaluations. To stimulate further participation among pedigree breeders, demand from commercial ram breeders will be critical. We would like to thank the IFA sheep representatives for our invite and look forward to making further progress with these groups as the year progresses.
- ♣ On Thursday we were in Portlaoise to speak to the National Sheep Breeders Association. There was a good attendance on the night with all main breeds represented. There were issues raised in relation to our evaluations and the role that certain measurements play in the final €uro-Star generation. There was also quite a bit of discussion in relation to our proposed LambPlus sales for 2012. We are going to take the opinions of as many parties as possible on board and discuss the matter at our next Sheep Ireland board meeting, at which point I have no doubt a decision can be made in relation to venues and dates etc, to hopefully satisfy all those involved. We have to emphasise that the objective here in Sheep Ireland is to add value to our sheep industry through the provision of better rams to the commercial farmer. Until such time as farmers and breeders become more educated about the potential benefits of the €uro-Stars, the LambPlus sales are a crucial promotional tool. A tool which participating breeders can use to great effect to attract progressive commercial ram buyers.
- ◆ On Thursday we also met with some of our MALP participants to run through plans for the 2012 lambing season. We also carried out some updates on the handheld devices that each of these farmers use to record their flock data for the €uro-Star evaluations. Hopefully the improvements we have made will pave the way for easier more efficient recording, while also ensuring that we here at Sheep Ireland collect as much relevant data as possible for our evaluations. The main body of discussion at this meeting centred around our evaluations and







especially our maternal index. There were many questions asked and great suggestions made in regard to possible future improvements to the index. It is hugely positive that this is where we are now with our MALP farmers and participating LambPlus breeders. We are quickly moving away from practical recording issues to more in depth evaluation issues and this is where we will make most significant genetic improvement in our industry. We look forward to further such discussion throughout 2012.
